### **General Information and Policies**

Thank you for choosing Happy Dog Care, Inc.'s Dog Daycare – The Safe, Healthy & Fun Place for Dogs to Stay While You're Away. The purpose of our Dog Daycare is to provide a safe, fun, and stimulating environment for dogs during weekday business hours. To ensure the safety and health of your pet and our other guests, we require all of our guests to comply with the following regulations:

**AGE:** All dogs must be at least 3 months of age or older.

**VACCINATIONS:** All dogs must be current on their vaccinations. Owners must submit written proof of DHLPP, Rabies and Bordetella (Canine Cough) vaccinations. The Bordetella vaccine must be boosted every year. Dogs must also be on flea preventative such as Frontline, Top Spot, Advantage, etc.

**HEALTH:** All dogs must be in good health. On admission all dogs must be free from any condition which could potentially jeopardize other guests. Dogs that have been ill with a communicable condition in the last 30 days will require veterinarian certification of health to be admitted or readmitted. Happy Dog Care, Inc. reserves the right to refuse a visit if your dog arrives sick or flea-infested.

**BEHAVIOR:** All dogs must be non-aggressive and not food or toy protective. Owners will certify that their dog(s) have not harmed or shown aggression or threatening behavior towards any person or any other dog(s). A dog that shows any signs of aggression will not be allowed to visit the Happy Dog Care Inc.'s Dog Daycare. Please remember: your dog will be spending time with other dogs and the safety and health of all animals is our main concern.

**APPLICATION:** All dogs must have a complete, up-to-date and approved application on file.

**FOOD & MEDICATION:** Food and Medications will be given as directed or prescribed. Please have food placed in serving-size baggies for the correct amount of days and feedings that your dog will be here.

**Please note:** There is a charge for medication application of \$1/day/dog.

**PERSONAL ITEMS:** We are not responsible for any personal items lost while in our care.

**FEES:** Fees are based on daily and hourly rates, package plans must be paid in full and are due in advance. Package plans are good for a limited time from purchase. For rates see the current Happy Dog Care, Inc.'s Daycare pricing schedule.

**DAYS AND HOURS:** Daycare hours are Monday through Friday from 6:30am to 6:30pm. Weekend daycare hours are 8am-9am for drop-off, and 5pm-6pm for pick-up. You **must** make reservations for weekend daycare.

I accept the inherent risks involved and agree that Happy Dog Care, Inc. and their staff will not be liable for any problems which develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation at Happy Dog Care, Inc.'s Dog Daycare.

I further understand and agree that Happy Dog Care, Inc. may videotape, audio tape, photograph or otherwise record or reproduce the image and sound of my dog(s) (the "Imagery") while at this facility, and Happy Dog Care, Inc. shall own all rights, title and interest in the Imagery. I further agree and consent that my dog(s) may be used by Happy Dog Care, Inc. to advertise, publicize or otherwise promote Happy Dog Care, Inc.

## Payment Requirements

1. I understand the fees schedule and agree to pay the current rate listed on Happy Dog Care Inc.'s price schedule for any fee services provided on the date my dog was in attendance.
2. I further understand and agree that the hours of operation are weekdays 6:30 am – 6:30 pm and a \$10/per 15 minute late fee charge applies from 6:30 pm to 7:00 pm to be paid for upon arrival. If I have not picked my dog up by 7:00 pm, Happy Dog Care, Inc. will board my dog on-site for an overnight boarding fee of \$55.
