General Information and Policies

Thank you for choosing Happy Dog Care, Inc.'s Dog Daycare – The Safe, Healthy & Fun Place for Dogs to Stay While You're Away. The purpose of our Dog Daycare is to provide a safe, fun, and stimulating environment for dogs during weekday business hours. To ensure the safety and health of your pet and our other guests, we require all of our guests to comply with the following regulations:

AGE: All dogs must be at least 3 months of age or older.

VACCINATIONS: All dogs must be current on their vaccinations. Owners must submit written proof of DHLPP, Rabies and Bordetella (Kennel Cough) vaccinations. The Bordetella vaccine must be boosted every year. Dogs must also be on flea preventative such as Frontline, Top Spot, Advantage, etc.

HEALTH: All dogs must be in good health. On admission all dogs must be free from any condition which could potentially jeopardize other guests. Dogs that have been ill with a communicable condition in the last 30 days will require veterinarian certification of health to be admitted or readmitted. Happy Dog Care, Inc. reserves the right to refuse a visit if your dog arrives sick or flea-infested

BEHAVIOR: All dogs must be non-aggressive and not food or toy protective. Owners will certify that their dog(s) have not harmed or shown aggression or threatening behavior towards any person or any other dog(s). A dog that shows any signs of aggression will not be allowed to visit the Happy Dog Care Inc.'s Dog Daycare. Please remember: your dog will be spending time with other dogs and the safety and health of all animals is our main concern.

APPLICATION: All dogs must have a complete, up-to-date and approved application on file.

FOOD & MEDICATION: Food and Medications will be given as directed or prescribed. Please alert the staff of either or any changes when you drop your dog off in the morning. Unless the item needs refrigeration, place the food or medication in your dog's cubby.

FEES: Fees are based on daily and hourly rates, package plans must be paid in full and are due in advance. Package plans are good for a limited time from purchase. For rates see the current Happy Dog Care, Inc.'s Daycare pricing schedule.

DAYS AND HOURS: Monday through Friday from 7 am to 6 pm. Happy Dog Care, Inc.'s Dog Daycare is NOT an overnight facility. Counselors go off duty at 6 pm and there will be a **\$10.00/ per 15-minute** charge for any dog remaining after 6 pm.

After 7:00 pm your dog will be boarded overnight for an additional \$50.

RESERVATIONS: Required. Preference will be given to dogs attending full time. Cancellations with less than 24 hours notice and no shows will be charged full fees.

Owner Agreement

1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending Happy Dogs Daycare, Inc.
2. I further understand and agree that in admitting my dog(s) to Happy Dog Care, Inc.'s Dog Daycare, that their staff have relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggression or threatening behavior towards any person or any other dog.
3. I further understand and agree that Happy Dogs Daycare, Inc.'s Dog Daycare is a cage-free facility and my dog(s) will play in open areas with other dog(s). I accept the inherent risks involved and agree that Happy Dog Care, Inc. and their staff will not be liable for any problems which develop, for any harm or accidents that could arise. I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation Happy Dog Care, Inc.'s Dog Daycare.
4. I further understand and agree that any problems which develop with my dog(s) will be treated as deemed best by the staff of Happy Dog Care, Inc., at their sole discretion, and that I assume full financial responsibility for any and all expensed involved.
5. I further understand and agree that if my dog displays aggressive behavior, that for the safety and health of my dog and others, my dog will either be confined to a separate room (with walks), for a portion of or the remainder of his/her stay with no offset or deduction in price, or be disqualified as a Happy Dog Care, Inc. customer.
6. I further understand and agree that Happy Dog Care, Inc. may video tape, audio tape, photograph or otherwise record or reproduce the image and sound of my dog(s) (the "Imagery") while at the our facility, and Happy Dog Care, Inc. shall own all rights, title and interest in the Imagery. I further agree and consent that my dog(s) may be used by Happy Dog Care, Inc. to advertise, publicize or otherwise promote Happy Dog Care, Inc.

Payment Requirements

1. I understand the fees schedule and agree to pay the current rate listed on Happy Dog Care Inc.'s price schedule for any fee services provided on the date my dog was in attendance.
2. I further understand and agree that the hours of operation are weekdays 7 am – 6 pm and a \$10/per 15 minute late fee charge applies from 6 pm to 7:00 pm to be paid for upon arrival. If I have not picked my dog up by 7:00 pm, Happy Dog Care, Inc. will board my dog off-site for an overnight boarding fee of \$50.
3. I understand that the Happy Dog Care, Inc. has the right to refuse service to my dog(s) and me at any time for any reason.
4. I understand that Happy Dog Care, Inc. will charge me a \$25 handling fee for returned checks.
5. Reservations are required. Cancellations with less than 24 hours notice and no shows will be charged full fees.
